#### Administrative matters

These Saturday morning sales maintain our community presence and enable more and more domestic gardeners to use wildplants for their home gardens. It is a vital community service to maintain which needs you, our volunteers!

We are outgrowing our premises at Clairvaux Centre and have been actively looking for more space for growing on our plants and even to relocate the entire nursery if more suitable premises can be found. We need a fairy godmother in the shape of an owner of a suitable industrial site (or other zoning suitable for a nursery) who would be willing to have us as a tenant. We have looked at several sites owned by Council but these have been unsuitable for one reason or another. The site needs to be secure and be connected to water and electricity so a watering system can be installed.

The nursery at Clairvaux will also need to be watered over the coming end of year break. Will someone please offer to set up this roster and maintain it for a couple of weeks over Xmas/New Year? A telephone network would be ideal so if someone rostered on has an emergency it is easy to contact someone else on the network to swap days. During the coming long hot and dry summer, the nursery also needs to be watered over weekends. Currently Alex and myself do this, however, a weekend off would be excellent – any takers?


